## Section 4: First aid measures

### 4.1. Description of first aid measures

First aid measures general: If exposed or concerned, get medical attention/advice. Show this Safety Data Sheet to the doctor in attendance. Wash contaminated clothing before re-use. Never give anything to unconscious person.

## Section 6: Accidental release measures

### 6.1. Personal precautions, protective equipment and emergency procedures

General measures: Evacuate area from non-essential personnel. Spill should be handled by trained clean-up crews properly equipped with respiratory equipment and full chemical protective gear (see Section 8). Ventilate area.

### 6.2. Environmental precautions

Avoid release to the environment. Prevent entry to sewers and public waters. Notify authorities if liquid enters sewers or public waters.

### 6.3. Methods and material for containment and cleaning up

For containment: Stop leak if safe to do so. Wear suitable protective clothing. Soak up small spill with inert solids. Collect spillage. Place in suitable container for disposal in accordance with the waste regulations.

Methods for cleaning up: Recover material for use if possible. Wash spill area thoroughly with plenty of water. Contain any spills with absorbents to prevent migration and entry into sewers or streams. Place in suitable container for disposal in accordance with the waste regulations (see Section 13).

## Section 7: Handling and storage

### 7.1. Precautions for safe handling

Handle in accordance with good industrial hygiene and safety procedures. Use appropriate personal protection equipment (PPE). Ensure adequate ventilation. Do not eat, drink, smoke, or use personal products when handling chemical substances.

### 7.2. Conditions for safe storage, including any incompatibilities

Store in a dry, cool, well ventilated place. Store above 40°F. Keep container tightly sealed. Store away from oxidizing agents.

### 8.2. Exposure controls

**Appropriate engineering controls:** Provide adequate general and local exhaust ventilation.

Where risk assessment shows, air-purifying respirators are appropriate, use a full-face particle respirator type N100 (US) or type P3 (EN 143) respirator cartridges as a backup to engineering controls. When necessary use NIOSH approved breathing equipment.

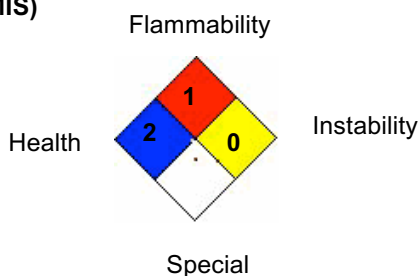
